

SIGNET LOYALTY OVERLAY SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF ARIZONA, CONNECTICUT, GEORGIA, ILLINOIS, INDIANA, NEW JERSEY, NEW YORK, TENNESSEE, OR WISCONSIN, 18 YEARS OF AGE OR OLDER. VOID IN ALL OTHER STATES, INCLUDING D.C., US TERRITORIES AND POSSESSIONS, AND WHERE PROHIBITED.

The Signet Loyalty Overlay Sweepstakes (“Sweepstakes”) is sponsored by Sterling Jewelers Inc. (“Sponsor”), 375 Ghent Road, Akron, Ohio 44333 and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 4, 2022 at 12:00 PM Eastern Time (“ET”) and ends on February 28, 2022 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes includes three (3) individual drawings during each of the entry periods (each an “Entry Period” and collectively the “Entry Periods”) as set forth in the chart below:

All entries must be received by the end time and date (detailed above) of each respective Entry Period to be valid and eligible. Non-winning entries will carry forward into subsequent Entry Periods. The Administrator’s computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of Arizona, Connecticut, Georgia, Illinois, Indiana, New Jersey, New York, Tennessee, or Wisconsin, who live in those states and are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Jared the Galleria of Jewelry® retail stores, Epsilon, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alabama, Alaska, Arkansas, California, Colorado, Delaware, Florida, Georgia, Hawaii, Idaho, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wyoming, D.C, US territories and possessions, and where prohibited or restricted by law.

Entering this Sweepstakes constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. HOW TO ENTER THE SWEEPSTAKES: During the Sweepstakes Period, an eligible entrant may visit <https://honeymoonsweps.com> (“Website”) and follow the links and instructions to enter the Sweepstakes. These Official Rules are also available on the Website. Incorrect or incomplete entries are void and will not be eligible. Note: In order to access the Website and in an effort to optimize the Website’s user experience, ad blocking software on your computer may need to be disabled. There are three (3) ways to earn entries in this Sweepstakes:

A. Register for the Sweepstakes: Complete and submit the registration form on the Website including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive two (2) entries into the Sweepstakes.

B. Sign up for the Vault Rewards By Jared™ Program: During the Sweepstakes Period, an eligible entrant may obtain additional entries by following the links and instructions to sign up for the Vault Rewards By Jared™ Program. There is no cost to sign up for the program. To enter the program, eligible entrants must provide a name, valid email address, and create a Jared.com account linked to that valid email address. Upon clicking the button to sign up, entrant will receive ten (10) additional entries into the Sweepstakes. If an entrant has already signed up for the program, they will automatically receive ten (10) entries into the Sweepstakes. C. Share with Friends: During the Sweepstakes Period, an entrant may obtain additional entries by following the instructions on the Website and set forth below to share the Sweepstakes via a Personalized URL. After successfully entering the Sweepstakes via the instructions in Section 3(A) herein, eligible entrants will be directed to a “thank you” page, which offers the option to obtain additional entries by sharing the Sweepstakes with friends. Upon clicking the button to share the Sweepstakes, a message with a unique link will be created which eligible entrants may share with friends (“Invitation Post”). To obtain additional entries, an entrant’s friend must be eligible to enter the Sweepstakes, click on the unique link in the Invitation Post, complete and submit the registration information requested, and enter the Sweepstakes. Upon the friend’s successful entry into the Sweepstakes, the original entrant will receive five (5) entries into the Sweepstakes. An entrant will receive five (5) entries for each friend who enters the Sweepstakes by following the unique link in his/her Invitation Post, up to maximum of forty (40) additional entries through this method.

Entry Limit: There is a limit of fifty-two (52) entries during the entire Sweepstakes Period. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize.

4. **RANDOM DRAWING:** On or around the dates set forth in Section 1, the Administrator will randomly select two (2) potential grand prize winners (1 per Entry Period) from the eligible entrants from the respective Entry Period, two (2) potential first prize winners (1 per Entry Period), and two (2) potential second prize winners (1 per Entry Period), from all eligible entries received in each Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
5. **PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**
 - A. **Grand Prizes (2, 1 per Entry Period):** Each grand prize is \$10,000 awarded via Chase QuickPay (“Grand Prize”). There will be two (2) Grand Prizes available in this Sweepstakes. To account for certain taxable amounts on the Grand Prize, Sponsor will increase the Grand Prize by \$5,540. However, winner is responsible for payment of all taxes on all monies received. The ARV of each Grand Prize is \$15,540.
 - B. **First Prizes (2, 1 per Entry Period):** Each first prize is a \$500 Jared Gift Card (“First Prize”). There will be two (2) First Prizes available in this Sweepstakes. The ARV of each First Prize is \$500.
 - C. **Second Prizes (2, 1 per Entry Period):** Each second prize is a \$250 Jared Gift Card (“Second Prize”). There will be two (2) Second Prizes available in this Sweepstakes. The ARV of each Second Prize is \$250.
 - D. **Total ARV:** The total ARV of all prizes in the Sweepstakes is \$32,580.
 - E. **Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
 - F. **General Conditions:** There is a limit of one (1) First or Second prize per person/household. To clarify, eligible entrants have the chance to win either a First or Second Prize, as well as a Grand Prize in any given Entry Period. However, once an entrant wins a First or Second Prize, or the Grand Prize, they are not eligible to win any prize in a subsequent Entry Period. winners via e-mail at the e-mail address provided at the time of registration. Each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the applicable Grand Prize, First Prize, or Second Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Sponsor reserves the right to conduct a background check on any potential winner and reserves the right in its sole discretion to disqualify any person based on such background check if Sponsor determines in its sole discretion that awarding the prize to such potential winner might reflect negatively on Sponsor or Administrator. Failure by potential prize winners to agree to a background check may also result in disqualification. Failure to provide all required information and a signature on the documents within the stated time period, or where the prospective prize winner does not pass Sponsor's background check (in its sole discretion), may result in forfeiture of a potential winner's right to claim his/her prize, and may result in the prize being awarded to an alternate potential winner, if time permits.
